- No mask, no service, no exceptions.
- With the exception of our Dover site, all sites are by appointment only. If you show up at a site to try to obtain an appointment, you will be turned away.
- You will see two types of service listed above:
 - o Tax Preparation/In-person this will be normal face-to-face tax preparation where all involved are masked and a plastic divider is present between the taxpayer and preparer
 - O Attended Intake/ Intake in this format, you will be dropping your paperwork off and complete the intake process. Your return will be completed off site and you will be contacted with any questions and when your return is ready for review and pick-up.
 - o Sites may use a combination of these models and may change their methods of operation throughout the season based on COVID-19 numbers.
- Due to decreased capacity, our sites are serving returning taxpayers first before determining if they have the capacity to serve new clients.
 - o The sites operating in this manor will be reaching out to their returning clients via phone or email.
- New clients must meet the following income guidelines and reside in Morris County or a bordering town:
 - o Married Filing Joint: \$90,000
 - o Single/ Head of Household: \$60,000
- If you have had your taxes done by AARP in the past and are not under the income listed above, we respectfully request that you return to AARP for your tax preparation needs.
